



**BEST SPEED BASEBALL ACADEMY  
COVID-19 RELEASE & LIABILITY; ACCEPTANCE OF RISK; RELEASE**

Indemnification. I am fully aware that there are a number of risks associated with me and/or my child or ward entering the Best Speed Baseball Academy (“Best Speed”) facility, becoming a member or guest, training and/or occupying a space at the Best Speed facility during the COVID-19 pandemic under the circumstances, including without limitation: (a) I and/or my child or ward or our visitors could contract COVID-19 or other diseases such as the flu or legionnaires disease which could result in a serious medical condition requiring medical treatment in a hospital or could possibly lead to death; and (b) I and/or my child or ward or our visitors will be subject to normal risks associated with occupying Best Speed such as physical injuries or even death or loss or damage to personal property, including without limitation, from slips or falls, food poisoning or allergic reaction to food served in the facility; physical or verbal altercations with guests, customers or staff, or other guests, electrocution from appliances or equipment within the Best Speed facility, pitching machine, netting, hit by ball, hit by hitting bat, terrorist or other violence, theft or vandalism, auto accidents around the Best Speed facility, or fires or other disasters affecting the facility. I understand I am not required to wear a mask inside the Best Speed facility to prevent from COVID-19 or other viruses that could lead to serious illness or death. On behalf of myself and/or my child or ward and our heirs, successors and assigns, I knowingly and freely assume all such risks, both known and unknown, relating to my and/or my child’s or ward’s occupancy of the Best Speed facility and being a guest, athlete, customer at Best Speed as described above, I hereby forever release, waive, relinquish, and discharge Best Speed, along with their officers, directors, managers, officials, trustees, agents, employees, or other representatives, and their successors and assigns (collectively, “Best Speed”), from any and all claims, demands, liabilities, rights, damages, expenses, and causes of action of whatever kind or nature, and other losses of any kind, whether known or unknown, foreseen or unforeseen, (collectively, “Damages”) as a result of me and/or my child or ward being a guest, customer, athlete, team, and renting, training, purchasing as described above, including but not limited to, those related to the above described personal injuries, death, disease, or property losses, or any other loss, and including but not limited to, claims based on the alleged negligence of any facility or representative or any other person. I further promise not to sue Best Speed or its representatives, and agree to indemnify and hold them harmless from any and all Damages resulting from my and/or my child’s or ward’s being a guest or occupying a space at the Best Speed facility.
